Tubex tree shelters provide a protected, growth-friendly environment for shrub and hardwood tree seedlings. In addition to offering protection from animals, wind, and chemical sprays, the shelters also provide a greenhouse environment which promotes seedling growth and reduces planting stress. Tubes are twin-walled, solid, translucent, and approximately 4 inches in diameter. Stakes not included.
